Each provision of the <u>R2 Standard</u> is designed to help ensure the transparency, quality, social and environmental responsibility of R2 Certified electronics facilities such as mobile resellers and recyclers. <u>R2:2013</u> was developed through a transparent multi-stakeholder process, consistent with <u>ANSI essential requirements</u>. R2 undergoes <u>consistent review</u> to advance the requirements in-line with the needs of the industry.
